2. HAZARDS IDENTIFICATION

Physical Properties

Symptoms of Acute Exposure (Naphthalene)

Symptoms from excessive prolonged inhalation exposure to naphthalene may include headache, dizziness and confusion. Ingestion of naphthalene may initially include jaundice, bloody urine, flank pain, anemia, red blood cell destruction, hemolysis and acute renal failure. Higher exposures may lead to lens opacity, temporary nervous system depression resulting in dizziness, headache, confusion, incoordination, loss of consciousness. Coma and fatality (gross overexposure) may also occur.

Symptoms of Chronic Exposure (N-methyl-2-pyrrolidone)

Prolonged exposure to n-methyl-2-pyrrolidone may include burning, redness, swelling, pain, blisters, cracking, or rash.

Primary Routes of Exposure

Oral, dermal, ingestion, inhalation

4. FIRST AID MEASURES

• Hold eye open and rinse slowly and gently with water for 15-20 minutes.

Remove contact lenses, if present, after the first 5 minutes, then continue rinsing.

If on Skin or Clothing:

If swallowed:

5. FIRE FIGHTING MEASURES

Flashpoint (test method): 98.9°C (210°F) Setaflash

Appropriate Extinguishing Media

Water spray, foam, dry chemical, CO₂

Fire Fighting Guidance

Evacuate personnel to a safe area. Keep personnel removed and upwind of fire. Wear self-contained breathing apparatus. Cool tank/container with water spray.

6. ACCIDENTAL RELEASE MEASURES

In Case of Spills or Leaks

Keep unnecessary people away and isolate hazard area. Dike spill. Prevent material from entering sewers, waterways or low areas. Soak up with sawdust, sand, oil dry or other absorbent material. Shovel or sweep up and then place in a chemical waste container for disposal. Handling

Engineering Controls

Use only with adequate ventilation. Keep container tightly closed.

User Safety Recommendations
